

ADDX Deposit Rewards Programme (“Promotion”)

Version Date: 26 Feb 2026

Terms and Conditions

This Promotion is organised by ADDX Pte. Ltd. (“ADDX”) and is valid from 11 March 2026 (00:00 SGT) to 11 June 2026 (23:59 SGT) (both dates inclusive) (“**Promotion Period**”).

For the avoidance of doubt, any Qualifying Deposit (as defined below) successfully credited into a Participant’s ADDX account on or before **11 June 2026 at 23:59 SGT** shall be considered a deposit made during the Promotion Period.

These terms (“Promotion Terms”) supplement the Platform Terms and Conditions and Exchange Rules. All terms used herein shall have the same meanings ascribed to them in the respective aforementioned terms and conditions, unless otherwise defined herein. For the avoidance of doubt, the ADDX Rewards Programme Terms and Conditions shall also apply and is binding on the Participant. By participating in this Promotion, a Participant agrees to and is bound by these Terms. Please refer to the ADDX Website for further information.

1. Definitions

For the purposes of this Promotion Terms, the following terms shall have such meanings ascribed to them:

“**Participant**” means a person who has opened a trading account on the ADDX Platform and whose trading account is valid and subsisting (whether or not suspended).

“**Qualifying Deposit**” means funds deposited into a Participant’s ADDX account during the Promotion Period that meet the applicable Reward Tier requirements.

“**Qualifying Investment**” means either (but not both) of the following: (a) subscription for an offering of new security tokens issued on the ADDX Platform, or (b) buy trade(s) on the ADDX Platform but, for the avoidance of doubt, does not include sell trade(s) on the ADDX Platform.

“**Net Deposit**” means the total amount of all Qualifying Deposit made into a Participant’s ADDX account during the Maintenance Period, minus the total amount of all withdrawals made during the same period.

“**Reward Tier**” refers to the Gold, Silver and Bronze tiers as set out in Clause 3.1.5.

“**Maintenance Period**” means the period of 90 days starting from the last date of the Qualifying Deposit during which the Participant must maintain the minimum Net Deposit amount for the applicable Reward Tier.

“**ADX\$**” means such sum(s) as may be credited to the trading account of any Participant on the ADDX Platform in connection with any Promotion in accordance with the ADDX Rewards Programme Terms and Conditions, as may be determined and/or adjusted by ADDX in its sole discretion from time to time.

2. Eligibility

2.1 This Promotion is open to existing ADDX Participants.

2.2 Each Participant may participate in this Promotion a maximum of one (1) time regardless of the number of Qualifying Deposits made. Participants are eligible to receive ADX\$ rewards for only one (1) Reward Tier.

3. Promotion Mechanics

3.1 Net Deposit Qualification

3.1.1 A Participant must make a Qualifying Deposit during the Promotion Period and fulfil the Maintenance Period requirement.

3.1.2 For the purposes of this Promotion, a Participant's Net Deposit shall be calculated as follows:

Net Deposit = Total Qualifying Deposit – Total Withdrawals made during the Maintenance Period

3.1.3 The Participant's eligibility for ADX\$ rewards and the applicable Reward Tier shall be determined based on the Net Deposit recorded at the end of the Maintenance Period.

3.1.4 A Participant shall be eligible to receive ADX\$ rewards for one (1) Reward Tier only, corresponding to the highest Reward Tier achieved based on their Net Deposit amount.

3.1.5 Please refer to Table 1 below for the Net Deposit amount required to qualify for each Reward Tier.

3.1 Deposit Qualification

3.1.1 A Participant must make a Qualifying Deposit during the Promotion Period and fulfil the Maintenance Period requirement.

3.1.2 A Participant may make one or more deposits during the Maintenance Period to meet the next Reward Tier.

3.1.3 Where additional deposits during the Maintenance Period result in an upgrade in Reward Tier, the Maintenance Period shall be recalculated from the last date of the Qualifying Deposit.

3.1.4 A Participant must maintain the respective Net Deposit amount for their applicable Reward Tier throughout the Maintenance Period to be eligible for the reward of ADX\$.

3.2 Eligibility for Additional Bonus of ADX\$

3.2.1 Participants may choose to make Qualifying Investment(s) using their Qualifying Deposit during the Maintenance Period.

3.2.2 Upon successful completion of the Qualifying Investment(s) corresponding to each Reward Tier, Participants can earn additional bonus ADX\$ as shown in Table 1 above.

3.2.3 To qualify for the additional bonus ADX\$ for a particular Reward Tier, Participants must complete the requisite number of Qualifying Investment(s), each made in a different subscription for an offering of new security tokens (a "Unique Investment"). Multiple investments in the same offering shall be aggregated and count as only one Unique Investment for the purposes of determining reward eligibility (as per Table 1).

3.3 Withdrawals and Reward Tier Reassessment

3.3.1 If a Participant makes any withdrawal during the Maintenance Period that results in a downgrade in Reward Tier, the Participant's eligibility shall be reassessed based on the aggregate Net Deposit amount at the end of the Maintenance Period.

3.3.3 A downgrade in Reward tier resulting from a withdrawal will not restart the Maintenance Period.

4. Reward Issuance and Claim

4.1 Subject to ADDX's verification of a Participant's full compliance with these Promotion Terms, ADX\$ rewards shall be credited in accordance with the ADDX Rewards Programme.

4.2 ADDX reserves the right to verify all Net Deposit, Qualifying Deposit, Qualifying Investments, balances and withdrawals before issuing any ADX\$.

4.3 All issuance of ADX\$ is subject to the ADDX Rewards Programme Terms and Conditions and the General Terms and Conditions set out below.

5. General Terms and Conditions

5.1 All terms used herein shall have the same meanings ascribed to them in the ADDX Rewards Programme's terms and conditions, ADDX Platform Terms and Conditions and ADDX Exchange Rules, unless otherwise defined herein.

5.2 To be entitled to ADX\$ under this Promotion, a Participant shall:

5.2.1 fulfil the qualifying criteria and meet all the requirements as set forth in this Promotion Terms; and

5.2.2 remain in compliance with all other prevailing terms and conditions of ADDX.

5.3 Participants who are found to be in breach of any such prevailing terms and conditions of ADDX may, at the ADDX's discretion, forfeit all accrued ADX\$ and/or their eligibility to participate in the ADDX Rewards Programme.

5.4 ADX\$ will not be credited into the Participant's ADDX trading account, until:

5.4.1 the Participant's successful completion of the specific Promotion is determined by ADDX to be valid; and

5.4.2 the Participant has gone to the Event page and manually click the claim button.

5.5 ADDX may cancel and/or delete and/or otherwise deduct ADX\$ that have already been credited into the Participant's trading at their absolute discretion, including under the following circumstances:

- 5.5.1 ADX\$ claimed in breach of any of these Promotion Terms and/or any other prevailing Terms and Conditions; and/or
 - 5.5.2 ADX\$ erroneously awarded due to system or computer glitches or any other reasons or errors or omissions.
- 5.6 ADX\$ has no cash value. ADX\$ are not redeemable for cash and are not transferable or assignable for any reason or any purpose. ADX\$ are not transferable between ADDX trading accounts. The sale, transfer, or assignment of any accrued ADX\$ is strictly prohibited, and any ADX\$ which ADDX deems at its absolute discretion to have been transferred, sold or assigned in violation of these Promotion Terms may be confiscated, deleted, forfeited and/or cancelled.

6. PERSONAL DATA

- 6.1 It is a continuing condition of the Participant's use of the ADDX Platform and participation in the Promotion, as well as their access to and use of the ADDX Platform that the Participant agrees to and consents that ADDX may collect, use and disclose such Participant's personal data as provided in the registration of their ADDX Platform, to its affiliates, service providers and partners, for the following purposes in accordance with the PDPA and ADDX's privacy policy available at ADDX Website:
- 6.1.1 to administer and manage this Promotion, including to contact the Participant and to conduct verification and other actions in connection with this Promotion for the processing the Participant's ADX\$ accruals; responding to the Participant's queries, requests and feedback;
 - 6.1.2 informing the Participant of changes and development to ADDX Rewards Programme and/or our policies, terms and conditions and other administrative information, including for the purposes of providing the products and services to the Participant; and
 - 6.1.3 conducting market research and/or analysis, carrying out surveys, improving customer service, managing, improving and enhancing the products and/or services of ADDX.
- 6.2 If a Participant requires access to their personal data, make any amendment or correction to their personal data, or wishes to withdraw consent to any specific use of their personal data, the Participant should email ADDX at dpo@addx.co.
- 6.3 The Participant acknowledges that if they choose to withdraw their consent for the collection, use and/or disclosure of their personal data, ADDX may not be able to continue providing the Participant with the products, services, promotions or benefits under the ADDX Rewards Programme.

7. Miscellaneous

- 7.1 The Participant agrees to be bound by these Promotion Terms and all other terms and conditions governing the use of such services or benefits in connection with the ADDX trading account, including but not limited to such terms and conditions as ADDX may stipulate, issue or publish from time to time in relation to any promotions, campaigns or programmes that ADDX may undertake or carry out from time to time, as the same may be amended or varied from time to time by ADDX. In the event of any inconsistency between these Promotion Terms and any other terms and conditions, these Promotion Terms shall prevail.

- 7.2 ADDX reserves the right, at its sole and absolute discretion and without needing to provide any reason or notice, to:
- 7.2.1 determine that any condition and/or requirement entitling any Participant to ADX\$ has not been fulfilled;
 - 7.2.2 not credit any ADX\$ to a Participant notwithstanding that the Participant has otherwise fulfilled the other requirements set out in these Promotion Terms to be credited with ADX\$.
- 7.3 ADDX shall not be required to inform any Participant whether such Participant is eligible for any entitlement to ADX\$.
- 7.4 ADDX reserves the right to delay reward distribution in cases of processing issues.
- 7.5 ADDX shall not be liable for any delay in crediting the ADX\$ to any Participant.
- 7.6 ADDX reserves the right to end or modify the Promotion at any time without prior
- 7.7 Under no circumstances whatsoever shall ADDX be liable for any indirect, punitive, incidental, special or consequential damages that result from, or arise out of the usage of any information stated herein or the participation in the ADDX Rewards Programme.
- 7.8 Notwithstanding any other terms and conditions in these Promotion Terms, each Participant agrees to:
- 7.8.1 release ADDX, its related corporations, affiliates, suppliers, advertising, and promotions agencies and their respective directors, officers, employees, and agents from any and all liability arising from any loss, harm, damages, cost, or expense, including without limitation, any property damages, personal injury and/or death, arising out of or in any way connected to any Promotion, and waives any claim to the same; and
 - 7.8.2 indemnify, defend, and hold ADDX, its related corporations, affiliates, and their respective representatives, directors, officers, employees, and agents harmless from and against any and all third party claims, demands, liabilities, costs, or expenses, including attorney's fees and costs, arising from, or relating to any breach of any of these Terms or any violation of applicable laws, rules and regulations.
- 7.9 Taxes. ADX\$ may be taxable depending on the country, state, and/ or local tax laws applicable to the Participant. Participants are solely responsible for reporting such items in their tax returns and paying any associated tax(es) and liabilities.
- 7.10 Although ADDX will use reasonable efforts to notify Participants of material changes to the ADDX Rewards Programme, it is the responsibility of Participants to keep themselves up to that. Any use of the ADDX Rewards Programme will be deemed as acceptance of any amendment.
- 7.11 ADDX may terminate or suspend, amend or update these Promotion Terms, in its sole and absolute discretion, at any time without providing prior notice.

7.12 Any determination made by ADDX in respect of all matters relating to this Promotion shall be at its sole and absolute discretion and shall be final, conclusive and binding on all Participants.

7.13 This Promotion Terms are governed by the laws of Singapore. Any dispute arising from these Terms are subject to the exclusive jurisdiction of the courts of Singapore.

7.14 A person who is not specified in these Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce any term of these Terms.
