

ADDX x SHINE Golf Charity Event ("Promotion")

Version Date: 18-May-2026

Terms and Conditions

This Promotion is organised by ADDX Pte. Ltd. ("ADDX") and is exclusively available to individuals who sign up for an ADDX account at the SHINE Golf Charity Event on 22 May 2026 ("Event").

The Promotion Period for account opening is from 22 May 2026 to 31 May 2026 (both dates inclusive).

The Promotion Period for Qualifying Investments is from 22 May 2026 to 30 September 2026 (both dates inclusive).

These terms ("Promotion Terms") supplement the Platform Rules and Exchange Rules. All terms used herein shall have the same meanings ascribed to them in the respective aforementioned terms and conditions, unless otherwise defined herein. For the avoidance of doubt, the ADDX Promo Code Terms and Conditions shall also apply and is binding on the Participant. By participating in this Promotion, a Participant agrees to and is bound by these Terms. Please refer to the ADDX Website for further information.

1. Definitions

For the purposes of these Promotion Terms, the following terms shall have such meanings ascribed to them:

"Participant" means a person who has signed up for an ADDX trading account at the Event on 22 May 2026 and whose trading account has been verified and approved by ADDX.

"New Investor" means a Participant who has not previously held an account on the ADDX Platform and has not previously made any investment on the ADDX Platform prior to the Event.

"Qualifying Investment" means either (but not both) of the following made during the Promotion Period: (a) subscription for an offering of new security tokens issued on the ADDX Platform, or (b) buy trade(s) on the ADDX Platform, but for the avoidance of doubt, does not include sell trade(s) on the ADDX Platform.

"Sign-Up Reward" means the EPON vouchers valued at SGD 400, redeemable upon successful verification of a Participant's ADDX trading account as set out in Clause 3.1.

"Investment Reward" means ADX\$ credits valued at SGD 3,000 credited to the Participant's ADDX Platform account, fulfillable upon a Participant's completion of a Qualifying Investment meeting the requirement set out in Clause 3.2.

2. Eligibility

2.1 This Promotion is open to New Investors only who sign up for an ADDX trading account in person at the Event using the promo code "SHINE2026" on 22 May to 31 May 2026.

2.2 Individuals who have previously held an ADDX trading account or made any investment on the ADDX Platform prior to the Event are not eligible to participate in this Promotion.

2.3 Each Participant may participate in this Promotion a maximum of one (1) time.

3. Promotion Mechanics

3.1 Sign-Up Reward

3.1.1 All eligible Participants who sign up for an ADDX trading account at the Event and whose accounts are successfully verified and approved by ADDX shall be entitled to one (1) Sign-Up Reward of EPON merchandise valued at SGD 400.

3.1.2 The Sign-Up Reward will be fulfilled after successful verification and approval of the Participant's ADDX trading account. ADDX will contact eligible Participants with fulfilment details following account verification.

3.1.3 Sign-Up Rewards are subject to availability. ADDX reserves the right to substitute the Sign-Up Reward with an item of equivalent or greater value at its sole discretion.

3.2 Investment Reward

3.2.1 In addition to the Sign-Up Reward, Participants who make a Qualifying Investment during the Promotion Period shall be entitled to one (1) Investment Reward of ADX\$ credits valued at SGD 3,000, credited to their ADDX Platform account.

3.2.2 There is no maintenance or lock-in period applicable to this Promotion. Reward eligibility is determined based on the Qualifying Investment amount made during the Promotion Period.

3.2.3 Each Participant is eligible to receive the Investment Reward a maximum of one (1) time.

3.2.4 ADX\$ credits forming the Investment Reward will be credited to the Participant's ADDX Platform account within a reasonable period following verification of the Qualifying Investment. ADX\$ credits are subject to the ADDX Promo Code Terms and Conditions.

4. Reward Issuance and Claim

4.1 Sign-Up Reward

4.1.1 The Sign-Up Reward will be processed and fulfilled following successful verification of the Participant's ADDX trading account. ADDX will notify eligible Participants of fulfilment details via email.

4.1.2 ADDX reserves the right to verify all account details and eligibility before fulfilling any Sign-Up Reward.

4.2 Investment Reward

4.2.1 Subject to ADDX's verification of a Participant's full compliance with these Promotion Terms, the Investment Reward in the form of ADX\$ credits shall be credited to the Participant's ADDX Platform account within a reasonable period following verification of the Qualifying Investment.

4.2.2 ADDX reserves the right to verify all Qualifying Investments and account details before fulfilling any Investment Reward.

4.2.3 ADDX will notify eligible Participants of Investment Reward fulfilment details via their registered contact information.

5. Personal Data

5.1 It is a continuing condition of the Participant's participation in this Promotion that the Participant agrees and consents that ADDX may collect, use and disclose such Participant's personal data as provided in the registration of their ADDX Platform account, to its affiliates, service providers and partners, for the following purposes in accordance with the PDPA and ADDX's privacy policy available at the ADDX Website:

5.1.1 to administer and manage this Promotion, including to contact the Participant and to conduct verification and other actions in connection with this Promotion for the processing of the Participant's rewards, and to respond to the Participant's queries, requests and feedback;

5.1.2 to inform the Participant of changes and developments to ADDX's policies, terms and conditions and other administrative information; and

5.1.3 to conduct market research and/or analysis, carry out surveys, improve customer service, and manage, improve and enhance the products and/or services of ADDX.

5.2 If a Participant requires access to their personal data, wishes to make any amendment or correction, or wishes to withdraw consent to any specific use of their personal data, the Participant should email ADDX at dpo@addx.co.

5.3 The Participant acknowledges that if they choose to withdraw their consent for the collection, use and/or disclosure of their personal data, ADDX may not be able to continue providing the Participant with the products, services, promotions or benefits under this Promotion.

6. Miscellaneous

6.1 Under no circumstances whatsoever shall ADDX be liable for any indirect, punitive, incidental, special or consequential damages that result from, or arise out of the participation in this Promotion.

6.2 Each Participant agrees to:

6.2.1 release ADDX, its related corporations, affiliates, suppliers, advertising and promotions agencies and their respective directors, officers, employees and agents from any and all liability arising from any loss, harm, damages, cost or expense, including without limitation any property damages, personal injury and/or death, arising out of or in any way connected to this Promotion, and waives any claim to the same; and

6.2.2 indemnify, defend and hold ADDX, its related corporations, affiliates and their respective representatives, directors, officers, employees and agents harmless from and against any and all third party claims, demands, liabilities, costs or expenses, including attorney's fees and costs, arising from or relating to any breach of any of these Terms or any violation of applicable laws, rules and regulations.

6.3 Taxes. Rewards received under this Promotion may be taxable depending on the country, state and/or local tax laws applicable to the Participant. Participants are solely responsible for reporting such items in their tax returns and paying any associated taxes and liabilities.
